

**GREATER VANCOUVER TRANSPORTATION AUTHORITY**  
**BY-LAW NO. 36-2004**

**A By-Law to amend the Greater Vancouver Transportation  
Authority 2004 Tariff Amendment By- Law Number 22-2001**

The Board of Directors of the Greater Vancouver Transportation Authority enacts  
as follows:

1. This By-Law may be cited as the “Greater Vancouver Transportation Authority 2004  
Tariff Amendment By-Law Number 36-2004.”

2. Delete the following conditions:

a) Part 3 – West Coast Express  
Section I – Terms & Conditions

Fares    Add-fares

Fare:

Adult (ii) For holders of a valid BC Transit Central Fraser Valley  
Service fare receipt or SuperPass a \$1.25 adult fare  
credit toward the fare payable to travel on West Coast  
Express.

and

Concession

(ii) For holders of a valid BC Transit Central Fraser Valley  
Service fare receipt or SuperPass a \$1.00 fare credit  
toward the fare payable to travel on West Coast  
Express.

3. Add the following conditions:

b) Part 3 – West Coast Express  
Section I – Terms & Conditions

Fare:

Adult (ii) For holders of a valid BC Transit Central Fraser Valley  
Service fare receipt or SuperPass a \$1.50 adult fare

credit toward the fare payable to travel on West Coast Express.

and

Concession

- (ii) For holders of a valid BC Transit Central Fraser Valley Service fare receipt or SuperPass a \$1.25 fare credit toward the fare payable to travel on West Coast Express.

## Appendix “B”

### Part 3 - West Coast Express

#### Section I – Terms and Conditions

##### Fares

###### Add-Fares

Available: To all eligible passengers from ticket vending machines.

Applicable: (i) To holders of a valid GVTA or Central Fraser Valley Transit System fare receipt/transfer, validated FareSaver or Monthly Pass for purchase of a one-way, return ticket, weekly ticket or 28-day pass.  
(ii) To holders of a valid U-Pass for purchase of a one-way, return or weekly ticket.

###### Fare:

Adult (i) For holders of a valid GVTA Transportation Service Region fare receipt/transfer, validated FareSaver ticket, FareCard, or U-Pass, a \$2.00 fare credit toward the fare payable to travel on West Coast Express;  
(ii) For holders of a valid BC Transit Central Fraser Valley Service fare receipt or SuperPass a \$1.50 fare credit toward the fare payable to travel on West Coast Express.

###### Concession

(i) For holders of a valid concession fare receipt, validated FareSaver ticket, FareCard, or U-Pass, a \$1.50 fare credit toward the fare payable to travel on West Coast Express.  
(ii) For holders of a valid BC Transit Central Fraser Valley Service fare receipt or SuperPass a \$1.25 fare credit toward the fare payable to travel on West Coast Express.
